- 2. Analyze at least two(2) narrative elements of any of the readings given. Explain how the story is told. From whose point of view? Describe the voice. How is the drama of scenes highlighted? In what mode or style is the story told? What are the roles of the minor characters, if any? Does the location of the story play a large part? Examine the contrasts (for example: light and dark; suspense and relaxation); how is the pace of the story affected by this rhythm? The answers to these questons, among others, will demonstrate your grasp of some of the Critical Reading techniques and principles discussed in class and in tutorials.
- 3. Choose any two(2) readings on 2 similar points (e.g. similarity of topic, similarity of rhetorical mode, similarity of point of view, similarity of degree of formality/informality). Contrast the two pieces -- what are their similarities? What are the differences?



Zimbabwe Act 1979

1979 CHAPTER 60

to make provision for, connection with the attainment by Zimbabwe of fully responsible status as a Republic. [20th December 1979]

Be it enacted by the Queen's most Excellent Majesty, by and with the advice and consent of the Lords Spiritual and Temporal, and in this present Parliament assembled, and by the authority of the same, as follows:

1.--(1) On such day as Her Majesty may by Independence in Council appoint (in this Act for Zimbabwe referred to as "Independence Day") Southern Rhodesia shall become an independent Republic under the name of Zimbabwe, and the unexpired provisions of the Southern Rhodesia Act 1965 shall cease to have effect.

- (2) On and after Independence Day Majesty's Government in the United Kingdom have no responsibility for government of Zimbabwe; and no Act of Parliament of the United Kingdom passed on or after that day shall extend, or be deemed to extend, to Zimbabwe as part of its law.
- (3) An Order in Council under section shall be laid before Parliament after being made.
- 2.--(1) In section l(3) of the British Nationality. Nationality Act 1948 (which specifies the 1948 c.56. countries whose citizens are by virtue that citizenship British subjects) the words "Southern Rhodesia" are hereby repealed as from Independence Day; and accordingly any person who immediately before that day is a British subject by virtue only of citizenship of Southern Rhodesia shall cease to be a British subject on that day.
