2. (a) Mr. Kia is the owner of vegetable farm located on a piece of land. Mr. Stream is the owner of a piece of land which is adjacent to Mr. Kia's vegetable farm. There is a stream running through the vegetable farm and Mr. Stream's land.

Mr. Kia has been carrying out vegetable farming activities on his land since 20 years ago. Mr. Stream was developing his land into a housing project and carried out earth works and tree felling.

There is a stream running through the vegetable farm and Mr. Stream's land. Encik Stream built a temporary earth road/embankment across the stream to enable Encik Stream's lorries and vehicles to cross. The said construction works has caused a backflow of water from the stream and caused flood. The flood waters reached a height of more than eight feet and totally submerged Mr. Kia's vegetable plants and damaged Mr. Kia's properties.

Mr. Stream contends that he carried out the earth works guided by plans drawn up by its surveyors, engineers and architects which were approved by the relevant authorities. Mr. Stream said the floods that occurred at that material time were beyond Mr. Stream's control and were an Act of God.

It was evidenced that the relevant authorities has imposed conditions requires Mr. Stream to take the necessary steps and measures to prevent landslides, floods and the like from happening not only to Mr. Kia's land but to surrounding areas as well. According to the approved plans, Mr. Stream was required to build a concrete bridge over the stream measuring at least 100 feet by 40 feet. However, there was no concrete bridge. Instead Mr. Stream built a temporary earth road cum embankment across the stream.

Now, Mr. Kia wants to claim loss and damages caused by flood waters from Mr. Stream. Please advise Mr. Kia according to tort principles and his legal rights.

2. (a) Encik Kia adalah pemilik ladang sayur-sayuran terletak di atas sekeping tanah. Encik Stream adalah pemilik sekeping tanah yang terletak bertentangan dengan ladang sayur-sayuran Encik Kia. Terdapat anak sungai yang merentasi ladang sayur-sayuran dan tanah Encik Stream.

Encik Kia telah mengusahakan aktiviti-aktiviti perladangan sayur-sayurannya di atas tanahnya sejak 20 tahun yang lalu. Encik Stream telah membangunkan tanahnya untuk projek perumahan dan telah membuat kerja-kerja tambakan tanah dan memotong pokok-pokok.

Terdapat anak sungai yang merentasi ladang sayur-sayuran dan tanah Encik Kia. Encik Stream telah membuat kerja-kerja penambakan tanah di atas tanahnya. Kerja-kerja penambakan tanah tersebut telah mengakibatkan aliran anak sungai tertutup dan mengakibatkan banjir. Banjir tersebut telah mencecah setinggi lebih daripada 8 kaki dan telah merosakkan kesemua pokok-pokok sayur dan harta-harta Encik Kia.

Encik Stream menyatakan bahawa dia telah menjalankan kerja-kerja penambakan tanah berdasarkan kepada plan yang dirangka dan dilukis oleh ‘surveyor’, juruter dan arkitek yang telah diluluskan oleh pihak berkuasa yang relevan. Encik stream menyatakan bahawa banjir tersebut berlaku adalah di luar kawalan Encik Stream dan ianya adalah perbuatan tuhan.

Telah dibuktikan bahawa pihak berkuasa yang relevan di dalam meluluskan pelan Encik Stream telah mengenakan syarat-syarat yang meminta Encik Stream mengadakan langkah-langkah kawalan yang mencukupi untuk mengelak kesan buruk seperti hakisan tanah dan banjir bukan sahaja di atas tanah Encik Kia tetapi juga bagi kawasan persekitarannya. Berdasarkan kepada pelan yang diluluskan.

Encik Stream dikehendaki membina jambatan konkrit menyeberangi anak sungai tersebut berukuran sekurang-kurangnya 100 kaki X 40 kaki. Namun, tiada jambatan konkrit yang dibina. Malah, Encik Stream telah membina jalan sementara dengan menambak tanah menyeberangi anak sungai tersebut.

Sekarang, Encik Kia hendak menuntut kehilangan dan gantirugi akibat banjir daripada Encik Stream. Sila nasihatkan Encik Kia berdasarkan prinsip-prinsip tort dan hak-haknya di sisi undang-undang.
