Question 1/Soalan 1 (30%)

Write short notes on the following.

- d. free market economy/*pasaran bebas*

Question 2/Soalan 2 (10%)

In your own words explain the following paragraph.

Jelaskan perenggan berikut menggunakan perkataan anda sendiri.

“The global economy poses threats to food security in several important ways. First, people who eat food are separated from the farms that produce it by great distances – economic, political, physical. Second, the rules of the global economy place the world’s food supply under the control of multinational corporations that have no allegiance to countries or their citizens. As a result, family-farm agriculture and the rural communities that depend on it are destroyed. Question 3/Soalan 3 (30%)

Identify the **major stakeholders** in the Thean Teik land-use dispute and their various positions regarding the land-use change. Comment on land-use change in rapidly urbanizing areas with respect to farming as an economic activity.

Nyatakan pelaku-pelaku penting dalam pertikaian guna-tanah Ladang Thean Teik dan pendirian tiap kumpulan berkenaan dengan perubahan guna-tanah. Question 4/Soalan 4 (30%)

Imagine that you are an urban planner working in the Urban Planning Department of the Majlis Perbandaran Pulau Pinang. You have assembled a research team to investigate technologies relevant to waste disposal. There are two choices; one is a “clean” incinerator, two is a land-fill. Identify the advantages and disadvantages of both technologies. Present your research team’s findings to a committee. Which technology is your technology of choice and state your reasons.

Question 5/Soalan 5 (30%)

The Athi Nahappan Report recommends that local government representatives be elected through local elections. Compare the advantages and disadvantages of the recommendation with the practice where local councillors are nominated by the state ruling party currently evident in Malaysia.

Question 6/Soalan 6 (30%)

What are the modes of transport that promote sustainable forms of transportation? Identify the various modalities of mobility for **short** (2 km. or less), **medium** (more than 2 km. but less than 5 km.) and **long distance** (more than 5 km.) as currently practiced in Malaysia.

Indicate on a scale of 1-9 (1 being most sustainable, 5 being moderately sustainable, 9 being the least sustainable) the Malaysian transport experience for **short**, **medium** and **long distances**. Explain your answer.

What are the measures that can be taken by the various stake-holders to improve the sustainability factor in transport in Malaysia.
