3. Rewrite the announcement below, using plain language.

Further to the press release dated 11 December 2020, relating to the proposed acquisition (the "Proposed Acquisition") of a suburban office property located at 1 – 5 Thomas Holt Drive, Macquarie Park, in Sydney, Australia ("1-5 THD"), Ascendas Funds Management (S) Limited, the Manager of Ascendas Real Estate Investment Trust ("Ascendas Reit") (the "Manager" of Ascendas Reit), is pleased to announce that the acquisition has been completed today.

The acquisition cost of S\$303.3 million1 (A\$308.5 million) comprises (i) the purchase consideration of S\$284.0 million (A\$288.9 million) and (ii) transaction costs of approximately S\$19.3 million (A\$19.6 million), which includes stamp duty, professional advisory fees and the acquisition fee payable to the Manager in cash (being 1% of the Purchase Consideration of S\$284.0 (A\$288.9 million, which amounts to approximately S\$2.840 million (A\$2.889 million)).

Further to the announcement dated 10 November 2020 in relation to the equity fund raising comprising a private placement and a pro-rata and non-renounceable preferential offering (collectively, the "Equity Fund Raising"), the Manager wishes to announce that approximately \$\$180.0 million (which is equivalent to approximately 15.0% of the gross proceeds of the Equity Fund Raising) of the gross proceeds from the Equity Fund Raising of approximately\$\$1,196.50 million, has been used to partially fund the Proposed Acquisition. This utilisation is in accordance with the use of proceeds and with the percentage allocated stated in the announcement dated 10 November 2020 in relation to the Equity Fund Raising. The Manager will make further announcements on the utilisation of the remaining proceeds from the Equity Fund Raising as and when such funds are materially disbursed.
